The undersigned, a majority of whom are citizens of the United States, desiring to form a corporation, not for profit, under Sections 1702.01 et seq., Revised Code of Ohio, do hereby certify:

FIRST. The name of said corporation shall be The Columbia Historical Society, Inc.

SECOND. The place in Ohio where the principal office of the corporation is to be located is

Columbia Township Lorain County.

(City, Village or Township)

THIRD. The purpose or purposes for which said corporation is formed are:

- (a) The collection, preservation, restoration, acquisition by purchase or by gift and ownership of historical objects, materials, records, articles of memorabilia arising out of and relating to the Township of Columbia and vicinity.
- (b) To preserve, collect and disseminate knowledge of the history of Columbia Township and surrounding areas.
- (c) To own, lease, occupy, acquire and use buildings, lands and rooms for the storage, preservation, promotion and display of historical articles and to operate or own a museum for that purpose.
- (d) To publish books, bulletins, brochures and pamphlets for the purpose of recording and disseminating the history of Columbia Township and vicinity and to encourage interest therein.
- (e) To collect, preserve and maintain accurate records in the future of memorable events relating to the development, progress and history of Columbia Township.
- (f) To receive and accept donations for these purposes of money, objects, articles, personal or real property, and the proceeds of trust funds established for that purpose; to act as trustee for property of any kind donated, loaned, bequeathed or devised to The Columbia Historical Society, Inc. by will, conveyance or by deed or gift.
- (g) To buy, sell, lease, mortgage and exchange any and all real and personal property which may be necessary, advantageous or proper in furtherance of the foregoing purposes.
- (h) In general, to do any and all things necessary or incidental to the accomplishment of any of the foregoing purposes, and to exercise and enjoy all additional powers, rights and privileges granted to corporations by the laws of the State of Ohio and all laws amendatory thereof or supplemental thereto now in effect or hereafter enacted.

FOURTH. The following persons, not less than three, shall serve said corporation as trustees until first annual meeting or other meeting called to elect trustees.
